1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1 POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - a. an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
 - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

TERMS OF REFERENCE:

APPOINTMENT OF A SERVICE PROVIDER TO SUPPLY, CONVERT, DELIVER AND PLACE A PREFABRICATED CONTAINER ABLUTION FACILITY CONSTRUCTED FROM A SHIPPING CONTAINER AND CONVERTED INTO A MALE AND FEMALE TOILET FACILITY

1. SCOPE OF WORK

The contractor shall be responsible for the supply, conversion, delivery and placement of a prefabricated container ablution facility constructed from a shipping container and converted into male and female toilet facilities. The ablution unit must be fully functional upon delivery, including all internal plumbing, electrical installations, sanitary fittings and ventilation. The container shall be divided internally into two separate sections, namely:

- Male Ablution Section
- Female Ablution Section

Each section shall have separate external entrances and be fully partitioned to ensure privacy and independent usage.

The facility must be suitable for public, or staff use and built using durable, weather-resistant and vandal-resistant materials.

2. CONTAINER STRUCTURE

2.1 Container Size

The ablution facility shall be constructed from:

- 1 x 6m (20ft) shipping container or equivalent modified steel container.

Minimum external dimensions:

- Length: 6 058 mm
- Width: 2 438 mm
- Height: 2 591 mm

The container must be:

- Structurally sound
- Rust treated
- Weatherproof
- Free from major dents or structural damage.

3. INTERNAL LAYOUT

The container must be internally partitioned into two separate sections, namely male and female ablutions. Each section must have independent access doors.

3.1 Male Section Must Include

- 2 x Flush toilets
- 2 x Urinals
- 1 x Wash hand basin
- 1 x Mirror above basin

Toilet cubicles must include:

- Lockable doors
- Privacy partitions
- Toilet roll holders

Urinals must include:

- Flush system
- Privacy divider between urinals

3.2 Female Section Must Include

- 2 x Flush toilets
- 1 x Wash hand basin
- 1 x Mirror above basin

Each toilet cubicle must include:

- Lockable cubicle doors
- Privacy partitions
- Toilet roll holders
- Sanitary disposal bin

4. INTERNAL PARTITIONING

The internal division between male and female sections must be constructed using:

- Moisture resistant partition boards
- Steel frame structure
- Smooth washable surfaces

Partitions must extend from floor to ceiling to ensure privacy and hygiene.

5. FLOORING

Flooring must be:

- Non-slip vinyl or epoxy coated flooring
- Waterproof
- Easy to clean
- Resistant to heavy use

Floor must include:

- Proper drainage gradient
- Floor drains where required

6. WALL FINISHES

Internal walls must be lined with:

- PVC cladding panels or fibre cement boards
- Waterproof finish
- Easy to clean
- Mould resistant

7. PLUMBING INSTALLATION

The supplier shall provide complete plumbing installation, including:

- Internal water piping
- Drainage piping
- Connection points for municipal services

The system must include:

- PVC piping
- Proper traps
- Shut-off valves
- Water-efficient flush systems

All plumbing must comply with:

- SANS Plumbing Standards
- Municipal bylaws

8. SANITARY FITTINGS

All sanitary fittings must be commercial grade and vandal resistant.

Minimum fittings required:

Male Section

- 2 x Ceramic toilet pans
- 2 x Urinals
- 1 x Wash basin
- 1 x Mirror
- 2 x Toilet roll holders
- Soap dispenser

Female Section

- 2 x Ceramic toilet pans
- 1 x Wash basin
- 1 x Mirror
- 2 x Toilet roll holders
- Soap dispenser

- 2 x Sanitary bins

9. ELECTRICAL INSTALLATION

The ablution facility must include complete electrical installation, including:

- Internal LED lighting
- Light switches
- Electrical distribution board
- External weatherproof connection point

Electrical installation must comply with:

- SANS 10142 Electrical Installation Regulations

Lighting must include:

- Minimum 2 LED lights per section

10. VENTILATION

Ventilation must be provided through:

- Aluminium louver vents OR
- Extractor fans

Each section must have adequate airflow to prevent odours and moisture build-up.

11. DOORS AND WINDOWS

External Doors

Each section must have:

- 1 x external steel security door
- Lockable handle
- Weather resistant finish

Total external doors required:

- 2 doors (Male and Female entrances)

Internal Cubicle Doors

- High-pressure laminate or PVC
- Lockable from inside
- Rust-resistant fittings

12. EXTERNAL FINISH

The container exterior must be:

- Rust treated
- Primed
- Painted with weather-resistant industrial paint

Colour:

- To be approved by the municipality.

13. SIGNAGE

Clear signage must be installed:

- Male Toilet
- Female Toilet

Signage must be:

- Weather resistant
- Clearly visible

14. DELIVERY AND PLACEMENT

The supplier must be responsible for:

- Transportation of the container
- Offloading
- Placement at the designated municipal site

Placement must include:

- Positioning on prepared ground or concrete slabs
- Ensuring the container is level and stable

All lifting equipment and transport costs must be included in the quotation.

15. QUALITY AND COMPLIANCE

The completed unit must comply with:

- SANS Building Standards
- Occupational Health and Safety Act
- Municipal plumbing regulations

All workmanship must be of high quality and suitable for public use.

16. WARRANTY

The supplier must provide:

- Minimum 12-month warranty on workmanship and materials.

17. COMPLETION

The ablution container must be delivered as a fully completed and operational unit, ready for connection to municipal services.
