1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1 POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is

A SERVICE PROVIDER FOR THE PROVISION OF SERVICES FOR STRIP, QUOTE & SERVICE OF MUNICIPAL SMALL PLANT AND EQUIPMENT FOR A PERIOD OF NINE (09) MONTHS AS AND WHEN REQUIRED.

BACKGROUND INFORMATION

uMngeni Municipality (Parks and Gardens Unit) intends to appoint a service provider for the repair and maintenance of lawnmowers, brush cutters, chainsaws, slashers and associated small plant as per list below, on an as-and-when required basis within the uMngeni jurisdiction, for the period of 9 months from the date of appointment. The municipality has many of lawnmowers, brush cutters, chainsaws, slashers and associated small plant, which need to be maintained. The municipality does not currently have capacity to service and repair the machines and equipment, as a result, general horticultural maintenance (including grass cutting and tree pruning), landscaping and greening services are negatively impacted. To expedite these repairs and maintenance, the Municipality has decided to solicit the services of service providers to services, repair and maintain these small plants/machines and equipment.

In light of the above, uMngeni Local Municipality requires the services of a qualified service provider with licenses to conduct maintenance in Stihl and Husqvarna to conduct routine and ad-hoc maintenance on its fleet of brush cutters and chainsaws. These tools are essential for maintaining municipal parks, gardens, and other public spaces.

OBJECTIVES

The primary objective of this contract is to ensure that all lawnmowers, brush cutters and chainsaws are maintained in optimal working condition, reducing downtime and extending the lifespan of the equipment. The service provider will be responsible for preventive maintenance, repairs, and performance checks. The contract will be effective for a 9 month period.

SCOPE OF WORK AND LIST OF ITEMS

The service provider shall be responsible for the following:

- **Preventive Maintenance:**
 - Regularly scheduled maintenance as per manufacturer recommendations.
 - Inspection of components including, but not limited to, engines, blades, fuel systems, and safety features.
 - Replacement of worn-out parts (e.g., spark plugs, air filters, blades).
- **Repairs:**
 - Diagnose and repair any mechanical or operational issues.
 - Replace faulty components with genuine or high-quality parts.
 - Test equipment post-repair to ensure functionality.
- **Performance Checks:**
 - Conduct operational tests after each maintenance or repair session.
 - Provide a detailed report on the condition of each piece of equipment.
 - Make recommendations for any necessary upgrades or replacements.
- **Record Keeping:**
 - Maintain detailed records of all maintenance and repairs conducted.

TIMEFRAMES

RESPONSE TIME: The service provider must submit the detailed services, repairs or maintenance report within 48 hours from the time of request. Work must be completed within 10 working days after receipt of an official order, Extension may be granted in exceptional circumstances.

MACHINE DELIVERIES

The municipality will deliver the equipment to be repaired to the service provider workshop or Contractor. The contractor will collect machines which are in need of repairs if the municipality is unable to load and deliver the machines due to the nature of the break down.

DETAILED REPORT BEFORE REPAIRS

Prior to commencing with any repairs the service provider must submit a detailed report indicating the parts to be replaced (by part number) and specifying the estimated number of hours (labour) required and any other incidental costs, for approval (in the form of a quote). The cost of producing said report (quote) is for the account of the service provider and no additional payment will be made.

REPAIRS

- The equipment to be repaired or overhauled shall be done strictly as per specifications on the accepted and approved quotation submitted. All repaired/maintained equipment handed over by the Service Provider, must be inspected and tested in presence of an official of the uMngeni Municipality to ensure that equipment has been properly repaired as per specifications.
- Should any of the repair costs, including labour costs be equivalent to or more than the cost of a new machine, the machine must be replaced with a new machine at the current price of the new machine. This must be accompanied with a report from the service provider indicating the detail costs including the repairs which are required.
- All materials used shall be original brand type (no "pirate" parts will be allowed) and shall be the best of its respective kind.

QUALIFICATIONS/ EXPERTISE AND EXPERIENCE

The service provider must have:

- Letters confirming Authorized Dealership and Service Status for Stihl and Husqvarna equipment.
- Physical Premise must be within uMngeni District (proof required – utility bill, etc).

INSURANCE

The service provider must provide comprehensive insurance cover for the municipal small plant while at his/her premises or in (his/her) transit. Minimum of R300 000 cover must be provided. Proof of insurance must be submitted.

PAYMENT

Quotes must be submitted to and approved by the Manager for Parks & Gardens at least 3 days before work commences. Invoices must reflect all work completed in the preceding month and are to be submitted upon completion of that work.

Invoices will be paid by the uMngeni Municipality on a monthly basis, provided that work was completed and verified by the Manager for Parks & Gardens for that month.
