1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner

required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. 1. PURPOSE

The purpose of this specification is to procure the supply, delivery and installation of a corrosion resistant galvanised welded mesh wire fence to replace the damaged section of fencing at 14 Essex Road, Howick, following storm and wind damage caused by a fallen tree.

2. SCOPE OF WORK

The successful service provider shall:

- Remove and dispose of the damaged fence material where required.
 - Secure and reinforce the existing wooden fence poles which remain structurally intact.
 - Supply and install approximately 12 metres of corrosion resistant galvanised welded mesh fencing.
 - Replace approximately 45 metres of existing 0.5 mm galvanised single-strand wire running from the front to the rear of the property.
 - Ensure all fencing components are properly tensioned, aligned and secured.
 - Leave the site clean and free from debris upon completion.

3. TECHNICAL SPECIFICATIONS

3.1 Fence Type

The fence shall consist of corrosion resistant galvanised welded mesh wire fencing suitable for outdoor environmental conditions and long-term durability.

3.2 Fence Height

- Fence height shall be 1.8 metres above ground level.

3.3 Mesh Aperture Size

- Mesh opening size shall be 50 mm x 50 mm square apertures.

3.4 Wire Material

- Welded mesh wire shall be manufactured from high-quality galvanised steel.
- The mesh shall be hot-dip galvanised or equivalent corrosion resistant finish suitable for external use.
- The galvanising coating shall provide protection against rust, corrosion and adverse weather conditions.

3.5 Wire Thickness

- Mesh wire diameter shall be a minimum of 2.5 mm or equivalent heavy-duty standard suitable for perimeter fencing applications.

3.6 Support Structure

- Existing wooden poles shall be inspected, straightened where necessary and securely anchored.

- Additional support brackets, fasteners or stays shall be installed where required to ensure structural stability.

3.7 Galvanised Strand Wire

- Supply and install approximately 45 metres of galvanised single-strand wire.
 - Wire shall be corrosion resistant and securely tensioned from the front to the rear boundary.

4. INSTALLATION REQUIREMENTS

The contractor shall ensure that:

- Fence alignment is straight and level.
 - Mesh is securely fixed to all support poles.
 - All fastening materials are galvanised and corrosion resistant.
 - Installation complies with acceptable construction and safety standards.
 - The completed fence is stable, secure and free from defects.

5. QUALITY REQUIREMENTS

- All materials supplied shall be new and free from defects.
 - Materials shall be suitable for outdoor environmental exposure and resistant to corrosion.
 - Workmanship shall be of a professional standard.

6. HEALTH AND SAFETY
